Communication will be clear and accessible to the general public, aiming to effectively promote disease prevention and control.

3) Expected Results:

- Encourage widespread public participation in disease prevention and control efforts
- Establish a dedicated support system for members committed to this cause, with a specialist assigned to each
- Integrate individuals who are loyal to this charity providing financial contributions, technical expertise or eloquence.

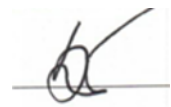
4) To qualify as a director:

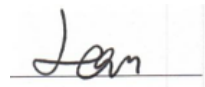
